Library Report

Review and amend ATV Ordinance: ATV Ordinance change to open Crystal Lake Road, Juneks Point Road from Crystal Lake Road to Birch Road and Birch Point Road from Junek's Point Road to River Road. Motion made by Jim Krueger to amend to open roads as read second by Jack McGregor Motion Carried.

Review Dog Ordinance: Several calls were made to the Sheriffs department about barking dogs. Robert Rasmussen will talk to the owners and call the Sheriff Department and see what can be done about the barking dogs.

Review Fireworks Permit. The ordinance is good, but the issue is enforcement. No changes were made.

Fire Department Budget: The fire department is requesting that they be allowed to pay credit card bills and then forward the bill to the town. They will pay bills that need to be paid and forward the bill to the clerk for reimbursement to the fire department.

Approve change to crack sealing: Scott Construction upgraded the estimate regarding the missed road; \$3105.00 will be added to the bill. The new bill is now \$24,219.00. Jim Krueger motion to approve the new bid for crack sealing second by jack McGregor. Motion Carried.
