

ORDINANCE # 11
HUNTING/FIREARMS ORDINANCE

STATE OF WISCONSIN

Town of Namakagon

Bayfield County

The Town of Namakagon does repeal and recreate the following:

SECTION I - TITLE AND PURPOSE

The title of this ordinance is the Town of Namakagon Hunting/Firearms Ordinance. The purpose of this ordinance is for the regulation of hunting and the discharge of firearms in specific areas of the town

SECTION II - AUTHORITY

The Town Board of the Town of Namakagon has the specific authority under s. 169.43, Wis. stats., and general authority under its village powers under s. 60.22, Wis. stats., to adopt this ordinance.

SECTION III - ADOPTION OF ORDINANCE

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, provides for the regulation of hunting and firearms in specific areas of the Town of Namakagon

SECTION IV - DEFINITIONS

In this ordinance:

- A. "Town" means the Town of Namakagon, Bayfield, County, Wisconsin.
- B. "Town board" means the board of supervisors for the Town of Namakagon, Bayfield County, Wisconsin, and includes designees of the board authorized to act for the board.
- C. "Town clerk" means the clerk of the Town of Namakagon, Bayfield County, Wisconsin.
- D. "Wis. stats." means the Wisconsin Statutes, including successor provisions to cited statutes.

SECTION V - SUBDIVISION AND NUMBERING OF THIS ORDINANCE

This ordinance is divided into sections designated by uppercase Roman numerals. Sections may be divided into subsections designated by uppercase letters. Subsections may be divided into paragraphs designated by numbers. Paragraphs may be divided into subdivisions designated by lowercase letters. Subdivisions may be divided into subdivision paragraphs designated by lowercase Roman numerals. Reference to a "section," "subsection," "paragraph," or "subdivision" includes all divisions of the referenced section, subsection, paragraph, or subdivision.

SECTION VI – RESTRICTIONS OF HUNTING AND FIREARMS

No person shall hunt with bow and arrow. No person shall discharge or hunt using a rifle, pistol, or shotgun with slug in the following areas.

- A. All of Junek Point from Birch Point Lane to Lake Namakagon.
- B. All of Missionary Point starting at the town line to Lake Namakagon.

No person shall hunt, or discharge a firearm, air rifle, or gas gun in the following areas.

- A. The Mary Livingston-Griggs Historical Special Management Area. This is the land from Garmisch Road north to Lake Namakagon.
- B. Burgundy Point of the Mary Griggs- Burke Scenic Special Management Area. This includes all Burgundy Point land from County highway “D” to Lake Namakagon.

All state laws regarding hunting and firearms apply in all areas of the Town of Namakagon.

SECTION VII - PENALTY PROVISION

Any person, partnership, corporation, or other legal entity that fails to comply with the provisions of this ordinance shall, upon conviction, pay a forfeiture of not less than \$1000, plus the applicable surcharges, assessments, and costs for each violation. In addition, the town board may seek injunctive relief from a court of record to enjoin further violations.

SECTION VIII - SEVERABILITY

If any provision of this ordinance or its application to any person or circumstances is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

SECTION IX - EFFECTIVE DATE

This ordinance is effective on publication or posting.

The town clerk shall properly post or publish this ordinance as required under s. [60.80](#), Wis. Stats.
