AT THE NAMAKAGON TOWN HALL**

- 1. Meeting called to order at 8:37 P.M. by Robert Rasmussen. Supervisors present Jack McGregor and Jim Krueger. Toni White, clerk, and Arlene Skultety, treasurer, present. Audience of 12.**
