Fire Dept:

meets the satisfaction of the fire department that the department purchase it

delivered on October 22<sup>nd</sup> and should be up by November Carrier will be  
Norvado.

Tax Collector Bond: Short term Tax Collector Bond. Motion made by Jim  
Krueger that we purchase the Tax Collector bond second by Bob Dolezal.

some repairs on the Paramedic House in Cable and build a garage. The  
Ambulance board voted to cut the town subsidies by 50% for the 2015  
budget.

Jim Schaffer: Would it be possible for the crew to plow the snow to the opposite side of the road? Request also made to plow Sugar Bay Drive the same way.
