Chairman Robert Rasmussen appointed a new member to the Comprehensive planning committee to replace Patsy Rieckhoff who is retiring from the position. Laurie Lyons has agreed to accept the appointment. The board would like to thank Patsy for her past 6 years of service.

Reviewed and discussed a new proposal that was received from Joe Zuelke; Scrap dealer. Since the board decided there are no issues with the current provider. No change in service will be made at this time.

Specs for new snow plow for 1 ton truck were discussed & confirmed. Clerk will send out request for sealed bids.

Jack McGregor made a motion to Adopt changes to Nuisance Ordinance #25 to be more consistent with the Bayfield County ordinance. The changes involve section #7, they are lighting, time limits on activities in town, and limits on RV/travel trailer parking on private property in the town. Jim Krueger 2^{nd} . Motion carried

Jim Krueger made a motion to Adopt ordinance #47 Clerk position change from Elected to Appointed. 2nd by Jack McGregor. Motion carried
