Chairman Rasmussen called the meeting to order at 7:30pm. Present were Chairman Rasmussen, Supervisors Jack McGregor and Jim Krueger, Treasurer Arlene Skultety and 3 others.

The agenda was posted at the Town Hall and on the website and the Daily Press was informed. The Pledge of Allegiance was recited.

The minutes from the previous meeting were presented. MOTION made by Supervisor McGregor to dispense the reading of the Town Board minutes from December 15<sup>th</sup> and approve them as presented. MOTION seconded by Chairman Rasmussen and carried.

The Financial Report was read by Treasurer Skultety; checks approved and signed #4281 through #4332. Town Financials are available to the public upon request to the Treasurer.

**Comprehensive Planning Report** – No report.

**Library Report** - The Library report will be posted on the website.

**Ordinance 41-C Rental Ordinance: Adjusting the Short-Term Rental Fee** – The \$100 Annual Fee was approved at the November 9<sup>th</sup> Town Board meeting. The ordinance needs to be updated to reflect change. The \$100 Annual Fee will be from June 1<sup>st</sup> to May 31<sup>st</sup>. The bill for this fee will be sent to the property owner. The Town Treasurer will send notices in the mail in March for the fee to be paid by June 1<sup>st</sup> of each year. This information will be reflected in the ordinance.

Ordinance 57-22 Ordinance to regulate stopping, standing, or parking of vehicles — There was an issue with parking on both sides of the street on Chicago Avenue restricting bigger vehicles, ambulance and fire trucks, from getting through. The signs that should be placed on Chicago Avenue should read "no parking on this side of the street". Supervisors McGregor and Krueger will work on the ordinance to be approved next month. Supervisor McGregor recommends that the town keep a spreadsheet of signs dating when and where the signs were put up.

Ordinance #25 Public Nuisance Ordinance – Tabled.

North End Ski Club – Will be on next month's agenda. Fire Department magazine was given to Supervisor McGregor. Chairman Rasmussen reviewed letter from Lemmenes for groundwater monitoring.

## **Public Comment**

Mike Jacobs had a concern with snowmobiles going by the hydrant on Missionary Point with the possibility of hitting it. That is public land; if the town marks it then they are responsible. This will not be marked.
