2023 Budget - Supervisor Krueger stated that the Forest Service might be willing to donate time during spring break up to help with the Garmisch project. The 2023 drafted budget was presented by Clerk Bjork. The board agreed to add LRIP funds for the Garmisch project. The Town Board will take time to consider the budget and discuss again at a work meeting.
