# ORDINANCE # 34 SPEED LIMIT ORDINANCE

STATE OF WISCONSIN Town of Namakagon Bayfield County

The Town of Namakagon does repeal and recreate the following.

## SECTION I - TITLE AND PURPOSE

The title of this ordinance is the Town of Namakagon Speed Limit Ordinance. The purpose of this ordinance is for the Town of Namakagon to set speed limits on town roads that need to have limits less than the state requirements.

### SECTION II - AUTHORITY

The Town Board of the Town of Namakagon has the specific authority under s. 175.25, Wis. stats., and general authority under its village powers under s. 60.22, Wis. stats., to adopt this ordinance.

# SECTION III - ADOPTION OF ORDINANCE

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, provides the authority for the town set speed limits on roads in the Town of Namakagon.

SECTION IV - SUBDIVISION AND NUMBERING OF THIS ORDINANCE

This ordinance is divided into sections designated by uppercase Roman numerals. Sections may be divided into subsections designated by uppercase letters. Subsections may be divided into paragraphs designated by numbers. Paragraphs may be divided into subdivisions designated by lowercase letters. Subdivisions may be divided into subdivision paragraphs designated by lowercase Roman numerals. Reference to a "section," "subsection," "paragraph," or "subdivision" includes all divisions of the referenced section, subsection, paragraph, or subdivision.

#### SECTION V- COVERAGE

A. Pursuant to s.349.11, Wis. Stats. Effective December 13, 2017, speed limits on certain Town of Namakagon town roads are reduced or modified as follows:

#### 45 Miles Per Hour

Dam Road from Cty. Hwy. M to Crystal Lake Road.

Crystal Lake Road from Dam Road to Town Line.

Juneks Point Road from Dam Road to a point 278 feet west of Birch Point Road.

#### 25 Miles Per Hour:

Bay Drive from South Circle Drive to end.

Bear Point Road from Junek's Point Road terminating 2390 feet in.

Birch Bend Road from Bayfield County Hwy. "D" on the south to Bayfield County Hwy. "D" on the north.

Birch Point Road from Junek's Point Road to end.

Chicago Ave. from Bayfield County Hwy. "D" to end.

Circle Drive North from Junek's Point Road to Circle Drive South.

Circle Drive South from Junek's Point Road to Circle Drive North.

Dodd Drive from Bayfield County Hwy. "D" to end.

Harmon Drive from Garmisch Road to end.

Missionary Point Road and Loop from the Namakagon town line.

Rock Lake Road (F.R.207) from Bayfield County Hwy. "M" to the Namakagon Town line.

Sugar Bay Road fron Bayfield County Hwy. "D" to end.

Viking Bay Drive from Bayfield County Hwy. "D" to end.

## 15 Miles Per Hour

Road into Transfer site from Cty. Hwy. M to end.

Bear Point Road starting 2390 feet from Junek's Point Road to end.

Duck Point Road from Garden Lake Road to end.

Any Town of Namakagon roads not listed above have a 35 mile per hour speed limit as per State of Wisconsin regulations.

- B. Pursuant to s.349.11(5), Wis Stats, the town chairperson, or his designee, shall place appropriate traffic signs at the above described locations on or before the effective date of this ordinance.
- C. No person may operate any vehicle on the above noted town roads in violation of the above speed limits. Any violation shall be subject to penalties under s. 346.60, Wis. Stats.

## SECTION VIII - SEVERABILITY

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

### SECTION IX - EFFECTIVE DATE

This ordinance is effective on December 13, 2017. The town clerk shall properly post or publish this ordinance as required under s. 60.80, Wis. stats. Adopted this 12th day of December, 2017.
