**MINUTES**

Chairman Rasmussen called the meeting to order at 7:30pm. Present were Chairman Rasmussen, Supervisors Jack McGregor and Jim Krueger, Treasurer Arlene Skultety, Clerk Bjork and 3 others.

The agenda was posted at the Town Hall and on the website and the Daily Press was informed. The Pledge of Allegiance was recited.

The minutes from the November meetings and October work meeting were presented. MOTION made by Supervisor Krueger to dispense the reading of the Town Board monthly minutes and approve them as presented. MOTION seconded by Supervisor McGregor and carried. MOTION made by Supervisor Krueger to approve the minutes from October 19<sup>th</sup> and November 16<sup>th</sup>. MOTION seconded by Supervisor McGregor and carried.

The Financial Report was read by Treasurer Skultety; checks approved and signed #5272 through #5327. Town Financials are available to the public upon request from the Treasurer.

**Letter of Support for the renovation of the Cow Palace building at the Forest Lodge Estate** – Ruth Goetz stated that the Forest Lodge is applying for an Act Grant, which is due in January. She is requesting support for the building, which will be funded in part by the grant. MOTION made by Supervisor McGregor to approve the letter of support for the renovation of the Cow Palace building at the Forest Lodge Estate. MOTION seconded by Supervisor Krueger and carried.

**Letter of Support for Bayfield County’s proposal to receive funding through the US Department of Transportation RAISE Discretionary Grant Program for the reconstruction of County Hwy A and County Hwy N** – It was noted that the roads were not in the township, however the roads are used by all. The road project was to make the 22 mile stretch of road an all-season road. MOTION made by Supervisor Krueger to approve the letter of support of Bayfield County’s proposal to receive funding through the US Department of Transportation RAISE Discretionary Grant Program for the reconstruction of County Hwy A and County Hwy N. MOTION seconded by Supervisor McGregor and carried.
