You are also to adhere to the following special conditions in the State of WI, Town of Namakagon, Bayfield County Fireworks Control Ordinance 27. A copy is available at the Town Office and on the town website, namakagon-wi.org:

- Cancellation of permit by Town Chairperson or designee due to weather or other environmental conditions.
- Clean up of any debris within 24 hours. Subject to fines listed in ordinance.
- As the named person on this permit you will be held responsible for compliance with all town, county and state laws, regulations, and ordinances regarding the use of fireworks.
- The use of fireworks is ONLY permitted between 9:00 AM and 11:59 PM on the date indicated on the permit.
- You agree that you are responsible for damage to public or private property.
- You may also be required to file a bond or liability policy, in the name of the Town of Namakagon, in the amount of \$100,000, that will indemnify other persons for any injuries to person or property arising out of the use of the fireworks.

I, the undersigned, do affirm that I have read and understand the requirements of Section 167.10 of the Wisconsin Statutes and Ordinance 27. A copy of the permit shall be given to Town of Namakagon Fire Dept., Community Services Officer, the Town Board and Bayfield County Sheriff's Dept. at least 2 days before the date of authorized use.
