If there is unpaid tax that is due when any of the persons licenses come due, the Town Treasurer shall recommend non-renewal until such tax, penalties and interest are paid. Each day, or portion thereof, that such violation continues is hereby deemed to constitute a separate offense. Any person that continually misses required payment dates shall be required to make monthly payments to the town for room tax taken in the previous month. Alarm	# 42	Any homeowner whose alarm system causes safety personnel to the residence and it is a false alarm will be subject to the charges. Any expense involved in clearing and gaining access to a driveway that is not clear will be the obligation of the owner. These charges will be added to the tax bill at the end of the year.
