# TOWN OF NAMAKAGON For - TOWN BOARD MEETING-Tuesday, May 13, 2025 At - NAMAKAGON TOWN HALL - 7:30pm MINUTES

Chairman Rasmussen called the meeting to order at 7:30pm. Present were Chairman Robert Rasmussen, Supervisors Jack McGregor and Jim Krueger, Treasurer Arlene Skultety, Clerk Laura Bjork and 16 others.

The agenda was posted at the Town Hall and on the website and the Daily Press was informed. The Pledge of Allegiance was recited.

The minutes from the March monthly meeting were presented. MOTION made by Supervisor Krueger to dispense the reading of the Town Board minutes and approve them as presented. MOTION seconded by Supervisor McGregor and carried.

The Financial Report was read by Treasurer Skultety; checks approved and signed #5934 through #6002. Town Financials are available to the public upon request from the Treasurer.

MOTION made by Supervisor Krueger to suspend the agenda and move to item #8. MOTION seconded by Supervisor McGregor and carried.

Power of Attorney for Forest Lodge Library – Carl Lippert stated that the Town of Namakagon and the Town of Cable own the Forest Lodge Library. A land use permit requires either the landowner's signature or an agent's via Power of Attorney. The agent for the library would be Thomas Westlund, the architect for the new building project. MOTION made by Supervisor McGregor to approve Thomas Westlund to represent the towns as the agent for the Power of Attorney, specifically for permits for the construction of the Forest Lodge Library. MOTION seconded by Supervisor Krueger and carried.

Comprehensive Planning Report – Dave Hanks reported that the county requested a review of their zoning districts, which was done by the commission and submitted to the county. There were some changes made and also some inquiries. The commission is working on a letter to the county to consider a speed reduction on County Hwy M from FR203 to Dam Road and also pedestrian crossings at Loon Saloon and PlayMor.

**Library Report** – The library report will be posted on the website.

**Great Divide Ambulance Report** – Laura Bjork reported that the service hired two more employees. There is a Medicaid Supplemental Payment Program that has opened through DHS, and the service will be a part of this program. Rob Puls retired as of May 19, 2025.

MOTION made by Supervisor McGregor to suspend the agenda and move to item #14. MOTION seconded by Supervisor Krueger and carried.

Wake Boat Ordinance – Tomi Backlund stated that she went to a meeting of the Northwest Lakes last Spring and this topic was discussed. She noted that enforcement would be a recreation specialist, which is part of the Sheriff's Department. Supervisor Krueger stated that the board has discussed this topic for years. He noted that there is information on wake boats in the Namakagon Lakes Association flyer. The problem with an ordinance is enforcing the ordinance. There was discussion on enforcement of such an ordinance. There was concern with other boats making the same wake and not being addressed the same way as the wake boats if an ordinance was created. The town could consider hiring a law enforcer, but it is expensive. Supervisor McGregor stated that the town currently is looking for voluntary compliance through education. Hayward has a wake ordinance, but they have their own boat and law enforcement for it. There was further

discussion on enforcement and issuing citations. It was noted that there are grant funds available. There was discussion on trying to change legislation by interacting with State Representatives on the matter.

Microsoft 365; One Drive Storage – The board agreed to purchase an upgrade to Microsoft 365.

**Pickleball Panels** – Kerri Nelson had requested the board consider purchasing some panels for ball control on the pickleball courts. The board agreed to purchase one and if it works well, the town would purchase 2 more with funds taken from park savings.
