MINUTES

Robert Rasmussen: The Board of Review is now in session for the Township of Namakagon on April 30, 2026 at 4pm. Present at this Board of Review is Robert Rasmussen, James Krueger, Arlene Skultety, Perri and Robert Campbell, Town Assessors and Clerk Laura Bjork.

Robert Rasmussen: Have all the proper BOR and Open Meetings been noticed?

Clerk Laura Bjork: Yes, the notice that the assessment roll is open for examination and open book with times for open book and board of review was posted on the web, and at the town hall and sent to the email list on April 7, 2026. The notice of the board of review meeting was posted on the web and at the Town Hall and sent the email list on April 7, 2026, and the BOR Agenda was posted on the web and at the Town Hall on April 7, 2026, with email notifications sent out that day.

Assessor Perri Campbell: All individual notices were sent out by statutory requirement with any changes to the assessment roll to the individual taxpayers on April 13, 2026.

MOTION made by Supervisor Krueger to appoint Robert Rasmussen for Chair of the Board of Review. Motion seconded by Arlene Skultety. All in favor. Motion carried.

Motion made by Chairman Rasmussen to appoint James Krueger for Vice-Chair of the Board of Review. Motion seconded by Arlene Skultety. All in favor. Motion carried.

Robert Rasmussen: Have all the training requirements for this Board of Review have been met?

Clerk Laura Bjork: Yes, the training requirements for this Board of Review were met by Arlene Skultety and the affidavit was filed on April 7, 2026.

Robert Rasmussen: The Town of Namakagon has on file Ordinance #51-20 Relating to Confidentiality of Income and Expenses Provided to Assessor for Assessment Purposes.

New Laws: None.

Robert Rasmussen: The town has an adopted policy regarding the procedure for waiver of the Board of Review hearing requests, which was adopted May 27, 2021.

Robert Rasmussen: The town has an adopted policy regarding the procedure for sworn telephone testimony and sworn written testimony, which was adopted May 27, 2021.

Robert Rasmussen: The Annual Assessment Report has been received and filed from the Assessor. The Assessment Roll has been received from the Assessor.

Robert Rasmussen: Were any Open Book changes made?

Perri Campbell:

Robert Rasmussen: Have any notices been received for the intent to file an objection?
